THE LIBRARY PROVIDED ACCESS TO 253,605 ITEMS IN ITS COLLECTION, INCLUDING IN-HOUSE AND OUTREACH COLLECTIONS, FOR USE BY THE PUBLIC AT NO CHARGE. THESE ITEMS WERE BORROWED 392,666 TIMES. THE LIBRARY'S PUBLIC INTERNET ACCESS COMPUTERS AND PUBLIC WI-FI WAS USED 33,096 TIMES; THE ONLINE DATABASE WAS ACCESSED 53,367 TIMES.
